Vicksburg National Military Park Boundary Modification Act of 2002 - Modifies the boundary of the Vicksburg National Military Park, Mississippi, to include property known as Pemberton's Headquarters. Authorizes the Secretary of the Interior to acquire, with the owner's consent, such property and at least one acre adjacent to or near such property to provide parking and other facilities related to operation of the Headquarters.

Authorizes appropriations.
