Judicial Branch Employment Nondiscrimination Act of 2001 - Amends the Civil Rights Act of 1964 to prohibit employment discrimination in the Federal Judiciary (currently, in Judiciary units having positions in the competitive service) based on race, color, religion, sex, or national origin.
