Expresses support for the people of India, for continuing and substantially increasing the amount of disaster assistance being provided by the United States Agency for International Development and other relief agencies, for providing future economic assistance, and for the economic assistance efforts of the World Bank, the Asian Development Bank, and the international community. Urges the President to use U.S. influence to expedite such efforts. Encourages assistance from other nations.
