Summary

 (as of May 20, 2002)

States that Congress recognizes the health and education needs of women who may be suffering from fibroids.

Expresses the sense of Congress that the medical community should explore alternatives to eliminating recurring fibroids by hysterectomy.

Encourages: (1) women to make regular OB/GYN visits; and (2) women and their physicians to know all safe options available for the prevention and cure of fibroids.
