Sets forth the rule (open) for the consideration of H.R. 2299 (FY 2002 Department of Transportation and related agencies appropriations).

Actions Timeline

- **Jun 26, 2001:** Mr. Reynolds moved to consider.
- **Jun 26, 2001:** POINT OF ORDER - Mr. Moran (VA) raised a point of order against consideration of H. Res. 178 on the grounds that it violated section 426(a) of the Congressional Budget Act in that it provided for an unfunded mandate. The House proceeded with 20 minutes of debate on the point of order. At the conclusion of debate on the point of order, the Speaker announced that the question would be put on the motion to consider the resolution.
- **Jun 26, 2001:** On motion to consider Agreed to by the Yeas and Nays: 219 - 202 (Roll no. 190).
- **Jun 26, 2001:** Considered by motion. (consideration: CR H3539-3549)
- **Jun 26, 2001:** DEBATE - The House proceeded with one hour of debate on H. Res. 178.
- **Jun 26, 2001:** The previous question was ordered without objection.
- **Jun 26, 2001:** Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 219 - 205 (Roll no. 191).(text: CR H3540)
- **Jun 26, 2001:** On agreeing to the resolution Agreed to by the Yeas and Nays: 219 - 205 (Roll no. 191). (text: CR H3540)
- **Jun 26, 2001:** Motion to reconsider laid on the table Agreed to without objection.
