### **Summary** (as of Sep 13, 2002)

San Gabriel River Watersheds Study Act of 2002 - Requires the Secretary of the Interior to study and report to specified congressional committees on the suitability and feasibility of establishing as a National Park System unit the watershed defined to include: (1) the San Gabriel River and its tributaries in Los Angeles and Orange Counties, California and (2) the San Gabriel Mountains within the territory of the San Gabriel and Lower Los Angeles Rivers and Mountains Conservancy.
