Sets forth the rule (modified closed) for the consideration of H.R. 2356 (bipartisan campaign reform).

Actions Timeline

- **Jul 12, 2001:** Introduced in House
- **Jul 12, 2001:** The House Committee on Rules reported an original measure, H. Rept. 107-135, by Mr. Reynolds.
- **Jul 12, 2001:** The House Committee on Rules reported an original measure, H. Rept. 107-135, by Mr. Reynolds.
- **Jul 12, 2001:** Rule provides for consideration of H.R. 2356 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Waives points of order against consideration of the bill. Measure will be considered read. Specified amendments are in order. Makes in order only those amendments printed in H. Rept. 107-135. Waives points of order against the amendments. After passage of the bill, it shall be in order to consider S. 27 and waives all points of order against the Senate bill. Makes in order a motion to strike all after the enacting clause of the Senate bill and insert in lieu thereof the provisions of H.R. 2356 as passed the House. Provides that if the motion to strike and insert is adopted and the Senate bill, as amended, is passed it shall be in order to move that the House insist on its amendment and request a conference with the Senate thereon.
- **Jul 12, 2001:** Placed on the House Calendar, Calendar No. 51.
- **Jul 12, 2001:** Considered as privileged matter. (consideration: CR H3980-3990)
- **Jul 12, 2001:** DEBATE - The House proceeded with one hour of debate on H. Res. 188.
- **Jul 12, 2001:** The previous question was ordered without objection.
- **Jul 12, 2001:** Failed of passage/not agreed to in House: On agreeing to the resolution Failed by the Yeas and Nays: 203 - 228 (Roll no. 228).(text: CR H3980)
- **Jul 12, 2001:** Motion to reconsider laid on the table Agreed to without objection.
