Summary (as of Sep 9, 2002)

Black Canyon of the Gunnison National Park and Gunnison Gorge National Conservation Area Boundary Revision Act of 2002 - Amends the Black Canyon of the Gunnison National Park and Gunnison Gorge National Conservation Area Act of 1999 to revise the boundary of Park to include specified Bureau of Land Management land which the Secretary of the Interior shall transfer to the administrative jurisdiction of the National Park Service.

Provides that if land authorized for the grazing is exchanged for private land under this Act, the Secretary shall transfer any grazing privileges to that private land. Permits grazing with respect to permits or leases issued to specified partnerships.

Requires such land acquisitions to be made in accordance with the Act and only with the landowner's consent.

Revises the boundary of the Conservation Area to add specified land.
