Expresses the sense of the Senate that the Government of the People's Republic of China should release the Panchen Lama, allow him to pursue his traditional role at Tashi Lhunpo monastery in Tibet, and enter into a dialogue with the Dalai Lama to find a solution for autonomy that respects the rights of all Tibetans.
