Postal Service Appropriations Act, 2003 - Makes FY 2003 appropriations for payments to the Postal Service Fund for revenue foregone on free and reduced rate mail.

Executive Office Appropriations Act, 2003 - Makes FY 2003 appropriations for the Executive Office of the President.

Independent Agencies Appropriations Act, 2003 - Makes FY 2003 appropriations for specified independent agencies.

Sets forth authorized uses of, and limitations on, such funds.
