Departments of Veterans Affairs and Housing and Urban Development, and Independent Agencies Appropriations Act, 2003 - Makes appropriations for FY 2003 for the: (1) Department of Veterans Affairs; (2) Department of Housing and Urban Development; (3) American Battle Monuments Commission; (4) Chemical Safety and Hazard Investigation Board (also addresses issues concerning the Board's Inspector General); (5) Department of the Treasury, Community Development Financial Institutions Fund Program Account; (6) Interagency Council on the Homeless; (7) Consumer Product Safety Commission; (8) Corporation for National and Community Service, including transfer of funds; (9) U.S. Court of Appeals for Veterans Claims; (10) Department of Defense-Civil; (11) Department of Health and Human Services, National Institutes of Health; (12) Agency for Toxic Substances and Disease Registry; (13) Environmental Protection Agency; (14) Hazardous Substance Superfund, including transfers of funds; (15) Council on Environmental Quality and Office of Environmental Quality; (16) Federal Deposit Insurance Corporation; (17) Federal Emergency Management Agency, including transfer of funds; (18) Federal Consumer Information Center Fund; (19) National Aeronautics and Space Administration, including transfer of funds; (20) National Credit Union Administration; (21) National Science Foundation; (22) Neighborhood Reinvestment Corporation; and (23) Selective Service System.
