Medicare Pharmacist Services Coverage Act of 2001 - Amends title XVIII (Medicare) of the Social Security Act (SSA), as amended by the Medicare, Medicaid, and SCHIP Benefits Improvement and Protection Act of 2000, to provide for Medicare coverage of pharmacist services.

- **Aug 16, 2001:** Referred to the Subcommittee on Health.
- **Aug 8, 2001:** Referred to the Subcommittee on Health.
- **Aug 2, 2001:** Introduced in House
- **Aug 2, 2001:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
