Encourages the Senate Committee on Appropriations to report 13 fiscally responsible and bipartisan appropriations bills to the Senate by July 31, 2002.

Restores and extends through April 15, 2003, the Senate pay-as-you-go point of order and the three-fifths supermajority vote requirement for certain waivers of the Congressional Budget Act of 1974, with a specified exception.
