Summary (as of Nov 6, 2001)

Safe Nursing and Patient Care Act of 2001 - Amends title XVIII (Medicare) of the Social Security Act (SSA) to place limitations on the mandatory overtime hours a nurse may be required to work in certain providers of services.

Actions Timeline

- **Nov 14, 2001:** Referred to the Subcommittee on Health.
- **Nov 6, 2001:** Introduced in House
- **Nov 6, 2001:** Sponsor introductory remarks on measure. (CR E2007)
- **Nov 6, 2001:** Referred to the Committee on Energy and Commerce, and in addition to the Committee on Ways and Means, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
