Quality Care for Nursing Home Patients Act of 2001 - Amends titles XVIII (Medicare) and XIX (Medicaid) of the Social
Security Act (SSA) to: (1) impose minimum direct care staffing requirements on nursing facilities receiving Medicare or Medicaid funding; (2) revise the Medicare, Medicaid, and SCHIP Benefits Improvement and Protection Act of 2000 with
respect to disclosure of staffing levels at such facilities, adding notice requirements; (3) prescribe administrative staffing
requirements for such facilities; and (4) apply quality of care requirements to all residents of skilled nursing facilities,
without regard to whether the resident is entitled to have payment made for nursing facilities under Medicare or Medicaid
