Sets forth the rule (modified closed) for the consideration of H.R. 2356 (bipartisan campaign finance reform).

Actions Timeline

- **Feb 12, 2002:** Considered as privileged matter. (consideration: CR H256-264)
- **Feb 12, 2002:** DEBATE - The House proceeded with one hour of debate on H. Res. 344.
- **Feb 12, 2002:** The previous question was ordered without objection.
- **Feb 12, 2002:** VOTE POSTPONED - At the conclusion of debate, the Chair put the question on adoption of the resolution and by voice vote, announced that the ayes had prevailed. Mr. Reynolds objected to the voice vote based on the absence of a quorum and pursuant to the rule, the Chair postponed further proceedings on the question of adoption of the resolution until later in the legislative day.
- **Feb 12, 2002:** Considered as unfinished business. (consideration: CR H266)
- **Feb 12, 2002:** Passed/agreed to in House: On agreeing to the resolution Agreed to by voice vote.(text: CR H256)
- **Feb 12, 2002:** On agreeing to the resolution Agreed to by voice vote. (text: CR H256)
- **Feb 12, 2002:** Motion to reconsider laid on the table Agreed to without objection.
- **Feb 7, 2002:** Introduced in House
- **Feb 7, 2002:** Rule provides for consideration of H.R. 2356 with 1 hour of general debate. Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Measure will be considered read. Specified amendments are in order. H. Res. 203 is laid on the table.
