The bill, as amended, shall be considered as the original bill for the purpose of further amendment and shall be considered as read. No further amendment shall be in order except those printed in part B of the report of the Committee on Rules. The amendments may be offered only in the order printed in the report, may be offered only by a Member designated in the report, shall be considered as read, shall be deb...
