Directs the Secretary of the Interior, acting through the Director of the National Park Service, to conduct a special resource study and report to Congress on the national significance of the Miami Circle (a prehistoric Tequesta Indian site) as well as the feasibility and suitability of including it in Biscayne National Park in Florida. Authorizes appropriations.
