## Summary (as of Jul 9, 2002)

Calls for the governments of Europe to: (1) continue to take necessary steps to provide security and to protect the safety and well-being of their Jewish communities; (2) deplore anti-Semitic expressions and prosecute and punish perpetrators of anti-Semitic violence; and (3) continue to make a concerted effort to cultivate an atmosphere in which all forms of anti-Semitism are rejected.

## Actions Timeline

- **Jul 9, 2002:** Mr. Gilman moved to suspend the rules and agree to the resolution, as amended.
- **Jul 9, 2002:** Considered under suspension of the rules. (consideration: CR H4380-4387, H4393-4394)
- **Jul 9, 2002:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 393.
- **Jul 9, 2002:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
