Revokes Public Land Order 3442, dated August 21, 1964, insofar as it applies to specified lands in Imperial County, California (lands included in Cibola National Wildlife Refuge).

Directs the Secretary of the Interior to resurvey and publish the new boundaries of the Refuge.
