Amends the Omnibus Consolidated and Emergency Supplemental Appropriations Act, 1999, as amended by other specified Federal law, to extend until June 1, 2002, the reenactment of chapter 12 of the Federal Bankruptcy Code (Adjustment of Debts of a Family Farmer with Regular Annual Income) (thereby extending family farmer bankruptcy relief).

Makes this Act effective as of October 1, 2001 (the previous expiration date).
