Summary (as of Oct 17, 2001)

Fort Clatsop National Memorial Expansion Act of 2001 - Authorizes the acquisition of certain additional lands for inclusion within the Fort Clatsop National Memorial in Oregon. Limits the total area for the Memorial to 1,500 acres. Requires the Secretary of the Interior to study the area known as Station Camp near McGowan, Washington, as well as the Megler Rest Area and Fort Canby State Park, to determine their suitability for inclusion in the National Park System.
