### **Summary** (as of Oct 1, 2002)

Southern Campaign of the Revolution Heritage Area Study Act - Directs the Secretary of the Interior to study and report to specified congressional committees on the suitability and feasibility of designating specified South Carolina counties, and, possibly, North Carolina sites, as the Southern Campaign of the Revolution Heritage Area. Specifies National Park Service sites, State-maintained sites, and communities of interest that may be included in the Heritage Area.
