Child Support Reinvestment Act of 2002 - Amends the Social Security Act to modify the formula used penalty for State failure to automate child support information systems if the State has submitted a complan approved by the Secretary of Health and Human Services. Directs the State to expend for operation of its approved State plan the amount by which it would have had it not submitted such corrective compliance plan.	rective compliance
