Southern California Wild Heritage Act of 2002 - Designates specified national forest and Bureau of Land Management district lands in California as wilderness and components of the National Wilderness Preservation System.

Designates specified California national park lands as wilderness and components of the System.

Designates specified California rivers as wild and scenic rivers.

Establishes the Ancient Bristlecone Pine Forest for public enjoyment and scientific study.
