to or from Cuba by U.S. Declares that: (1) this proconsumption acquired in the United States is at w	uba Act of 2002 - Prohibits the President from regulating or prohibiting, directly or indirectly, traversitizens or legal residents, or any of specified transactions incident to such travel. To hibition does not authorize the importation into the United States of any goods for personal in Cuba; and (2) the restrictions on authority contained in this Act do not apply in a case in which war with Cuba, armed hostilities between the two countries are in progress, or there is imminent alth or the physical safety of U.S. travelers.
