**Summary** (as of Feb 8, 2001)

Higher Education Affordability Act - Amends the Internal Revenue Code to exclude from income distributions from qualified tuition programs used for qualifying higher education expenses.

Includes within the definition of "qualified State tuition program" programs maintained by eligible educational institutions.
