### **Summary** (as of Oct 2, 2002)

Declares the sense of the House of Representatives that Congress should complete action on H.R. 4019 (permanent marriage penalty tax relief) and present it to the President before adjournment of the 107th Congress, so that 36,000,000 married couples can benefit from permanent marriage penalty tax relief.

### **Actions Timeline**

- Oct 2, 2002: Considered under the provisions of rule H. Res. 547. (consideration: CR H6933-6940)
- Oct 2, 2002: Rule provides for consideration of H. Res. 540, H. Res. 544 and H. Res. 543. Measure will be considered read. Bill is closed to amendments.
- Oct 2, 2002: DEBATE The House proceeded with one hour of debate on H. Res. 543.
- Oct 2, 2002: The previous question was ordered pursuant to the rule.
- Oct 2, 2002: POSTPONED ROLL CALL VOTE At the conclusion of debate on the resolution, the Chair put the question on adoption of the resolution and by voice vote, announced that the ayes had prevailed. Mr. Weller objected to the voice vote based upon the absence of a quorum and the Chair postponed further proceedings on the question of adoption of the resolution until later in the legislative day. The point of no quorum was considered as withdrawn.
- Oct 2, 2002: Considered as unfinished business. (consideration: CR H6951-6952)
- Oct 2, 2002: Passed/agreed to in House: On agreeing to the resolution Agreed to by the Yeas and Nays: 285 130 (Roll no. 430).(text: CR H6933)
