Summary (as of Sep 10, 2001)

Directs the Administrator of General Services to convey to the City of Kewaunee, Wisconsin, a parcel of Federal real property that is located at 401 5th Street in Kewaunee and that contains an excess Army Reserve Center. Allows such property to be used and occupied only by the city, or by another local or State government entity approved by such city, after such conveyance and prohibits the use of such property for commercial purposes.
