Condemns the repressive and totalitarian actions of the Cuban Government against the Cuban people.

Expresses the sense of the House of Representatives that the President should: (1) have an action-oriented policy of directly assisting the Cuban people and independent organizations to strengthen the forces of change and to improve human rights within Cuba; and (2) make all efforts necessary at the meeting of the United Nations Human Rights Commission in Geneva in 2001 to obtain passage of a resolution condemning the Government of Cuba for its human rights abuses and to secure the appointment of a Special Rapporteur for Cuba.

- Apr 3, 2001: At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
