Medicare Disability Eligibility Improvement Act of 2003 - Amends title XVIII (Medicare) of the Social Security Act to eliminate the 24-month waiting period for disabled individuals to become eligible for Medicare benefits.

Actions Timeline

- **Jan 23, 2003:** Referred to the Subcommittee on Social Security.
- **Jan 8, 2003:** Referred to the Subcommittee on Railroads.
- **Jan 7, 2003:** Introduced in House
- **Jan 7, 2003:** Referred to the Committee on Ways and Means, and in addition to the Committees on Energy and Commerce, and Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned.
