Summary (as of Jan 31, 2003)

(This measure has not been amended since it was introduced in the House on January 27, 2003. The summary of that version is repeated here.)

Amends Public Law 107-229 to extend until February 7, 2003, specified continuing appropriations for FY 2003.

Previous question shall be considered as ordered without intervening motions except motion to recommit with or without instructions. Debate is equally divided and controlled by the chairman and ranking minority member of the Committee on Appropriations. All points of order against consideration of the joint resolution are waived. Resolution provides that upon receipt of a message from the Senate transmitting H.J.Res. 2 with a Senate amendment thereto, it shall be in order to consider in the House a motion offered by the chairman of the Committee on Appropriations or his designee that the House disagree to the Senate amendment and request or agree to a conference with the Senate thereon. Measure will be considered read. Bill is closed to amendments.
- Jan 28, 2003: DEBATE The House proceeded with one hour of debate on H.J. Res. 13.
- Jan 28, 2003: The previous question was ordered pursuant to the rule.
- Jan 28, 2003: Mr. Obey moved to recommit with instructions to Appropriations.
- Jan 28, 2003: Mr. Putnam raised a point of order against the motion to recommit with instructions. The provisions of the motion to recommit violate section 302 (c) of the Budget Act. Sustained by the Chair.
- Jan 28, 2003: Point of order sustained against the motion to recommit with instructions.
- Jan 28, 2003: Mr. Obey appealed the ruling of the chair. The question was then put on sustaining the ruling of the chair.

The instructions contained in the motion seek to require the Committee on Appropriations to report the joint resolution back to the House with amendments to provide \$3.5 billion in homeland security grants to equip first responders, and to provide \$90 million for the Centers for Disease Control for baseline health screening and long-term medical monitoring of emergency response and recovery personnel exposed to toxic substances at the WTC site.
