Sets forth the rule for consideration of S. 23 (five-month extension of the Temporary Extended Unemployment Compensation Act of 2002).

- **Jan 7, 2003:** Rule providing one hour of debate in the House equally divided and controlled by Representative Thomas of California and Representative Rangel of New York. Waives all points of order against consideration of the bill. Provides that Section 2 of the resolution provides that the allocations referred to in section 3(a)(4)(B)(i) of H. Res. 5 may be submitted by Representative Nussle of Iowa.
- **Jan 7, 2003:** Placed on the House Calendar, Calendar No. 1.
