Summary (as of Jul 17, 2003)

Foreign Operations, Export Financing, and Related Programs Appropriations Act, 2004 - Makes appropriations for FY 2004 for: (1) the Export-Import Bank of the United States; (2) the Overseas Private Investment Corporation; (3) the Trade and Development Agency; (4) expenses of the President in carrying out certain programs under the Foreign Assistance Act of 1961; (5) U.S. Agency for International Development; (6) various bilateral economic assistance programs for foreign developing countries; (7) the Inter-American Foundation, the African Development Foundation, and the Peace Corps; (8) international narcotics control and law enforcement and the Andean Counterdrug Initiative; (9) migration and refugee assistance; (10) nonproliferation, anti-terrorism, demining and related programs; (11) Department of the Treasury for international affairs technical assistance and debt restructuring; (12) expenses of the President for Millenium Challenge Assistance to certain countries through the Millenium Challenge Corporation (which the President is hereby authorized to establish); (13) certain U.S. military assistance programs for foreign countries; (14) U.S. contributions to certain international financial institutions; and (15) international programs and organizations.

Sets forth certain limits and prohibitions on the use of appropriations for specified activities.
