Sets forth the rule for consideration of H.R. 743 (amending the Social Security Act and the Internal Revenue Code with regard to representative payees of Social Security and Supplemental Security Income beneficiaries).

Res. 168, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Mr. Frost demanded the Yeas and Nays and the Chair subsequently postponed further proceedings on the question until later in the legislative day.
