Amends the Irrigation Project Contract Extension Act of 1998 to provide for the extension of water service or repayment contracts for the Glendo Unit of the Missouri River Basin Project and the Cooperative Agreement for Platte River Research and other Efforts Relating to Endangered Species Habitats Along the Central Platte River, Nebraska, until December 31, 2005.
