Sets forth the congressional budget for the Federal Government for FY 2004, including the appropriate budgetary levels for FY 2005 through 2013.

Lists recommended budgetary levels and amounts, for FY 2003 through 2013, with respect to: (1) Federal revenues; (2) new budget authority; (3) budget outlays; (4) deficits; (5) public debt; and (6) debt held by the public.

Lists the appropriate levels of new budget authority and outlays for Social Security and specified major functional categories for FY 2003 through 2013.

Extends congressional supermajority enforcement requirements and Senate discretionary spending limits.

Prohibits Senate legislation that would require advanced appropriations and legislation that would increase the on-budget deficit or cause an on-budget deficit.

Sets forth committee reconciliation instructions.

Provides for certain reserve funds, including those for emergencies, Medicare reform, health insurance for the uninsured, highways and highway safety and transit, children with special needs, Project Bioshield, the Stateside Grant Program, and children's health insurance.
