Each amendment printed in the report shall be debatable for 10 minutes (unless otherwise specified in the report). Authorizes the chairman of the Committee on Armed Services or his designee to offer amendments en bloc consisting of amendments printed in the report, or germane modifications thereto, which shall be considered as read (except that modifications shall be reported), and shall be debatable for 20 minutes.
