Recognizes the 60 years of service of Fort Detrick, Maryland, to the Nation.

Commends Army military and civilian personnel, other elements of the Department of Defense, and other Federal departments and agencies who have worked at Fort Detrick to: (1) defend the United States against biological and chemical attack; and (2) develop vaccines for all types of illnesses.
