(This measure has not been amended since it was reported to the House on June 25, 2004. The summary of that version is repeated here.)

Newlands Project Headquarters and Maintenance Yard Facility Transfer Act - Directs the Secretary of the Interior to convey to the Truckee-Carson Irrigation District in Nevada real property within the Newlands Project, Nevada, known as 2666 Harrigan Road, Fallon, Nevada, after: (1) compliance with requirements relating to the National Environmental Policy Act of 1969 and cultural resources; and (2) completion of necessary environmental site assessments, remediation, or removal.

Directs that amounts received by the United States for the lease and sale of Newlands Project lands comprising the Fallon Freight Yard be treated as payment in full consideration for the property conveyed under this Act.

Requires the Secretary to report to Congress if the conveyance has not been completed within 12 months after this Act's enactment. Shields the United States from liability for damages arising out of any act or omission by the District or its employees, agents, or contractors relating to the property conveyed and occurring prior to, on, or after the date of conveyance.
