Sets forth the rule for the consideration of H.R. 2211 (reauthorization of title II (Teacher Quality Enhancement) of the Higher Education Act of 1965).

Actions Timeline

- **Jul 9, 2003:** DEBATE - The House proceeded with one hour of debate on H. Res. 310.
- **Jul 9, 2003:** The previous question was ordered without objection.
- **Jul 9, 2003:** POSTPONED VOTE - The Chair put the question on adoption of the resolution and by voice vote, announced that the ayes had prevailed. Mr. McGovern asked for the yeas and nays and the Chair postponed further proceedings until later in the legislative day.

- **Jul 8, 2003:** Provides that the amendment in the nature of a substitute recommended by the Committee on Education and the Workforce now printed in the bill shall be considered as an original bill for the purpose of amendment under the five-minute rule. Makes in order only those amendments printed in House Report 108-190. Provides that the amendments printed in the report shall be considered only in the order printed, offered only by a Member designated in the report, considered as read, shall be debatable for the time specified, equally divided and controlled, shall not be subject to amendment, and shall not be subject to a demand for a division of the question in the House or in the Committee of the Whole. Waives all points of order against the amendments printed
