Sets forth the rule for the consideration of H.R. 2657 (FY 2004 legislative branch appropriations).

Actions Timeline

- **Jul 9, 2003:** Considered as privileged matter. (consideration: CR H6393-6396)
- **Jul 9, 2003:** DEBATE - The House proceeded with one hour of debate on H. Res. 311.
- **Jul 9, 2003:** The previous question was ordered without objection.
- **Jul 9, 2003:** POSTPONED PROCEEDINGS - The Chair put the question on passage of the resolution, as amended, by voice vote and announced that the yeas had prevailed. Ms. Slaughter objected to the voice vote based on the absence of a quorum. The Chair subsequently announced that further proceedings were postponed until later in the legislative day.
- **Jul 9, 2003:** Considered as unfinished business. (consideration: CR H6418-6419)
- **Jul 9, 2003:** Passed/agreed to in House: On agreeing to the resolution Agreed to by recorded vote: 411 - 13 (Roll no. 342).
- **Jul 9, 2003:** On agreeing to the resolution Agreed to by recorded vote: 411 - 13 (Roll no. 342).
