Sets forth the rule for the consideration of H.R. 2799 (FY 2004 Departments of Commerce, Justice, and State, the Judiciary, and related agencies appropriations).

  waives points of order against provisions in the bill for failure to comply with clause 2 of rule XXI (prohibiting
  unauthorized appropriations or legislative provisions in an appropriations bill), except as specified in the resolution.
  Authorizes the Chair to accord priority in recognition to Members who have pre-printed their amendments in the
  Congressional Record.
