Sets forth the rule for the consideration of H.R. 2861 (FY 2004 Departments of Veterans Affairs and of Housing and Urban Development and independent agencies appropriations).

Actions Timeline

- Jul 25, 2003: Considered as privileged matter. (consideration: CR H7630-7637)
- Jul 25, 2003: DEBATE The House proceeded with one hour of debate on H. Res. 338.
- Jul 25, 2003: The previous question was ordered without objection.
- Jul 25, 2003: POSTPONED ROLL CALL VOTE At the conclusion of debate on H. Res. 338, the Speaker put the question on adoption of the resolution and by voice vote, announced that the ayes had prevailed. Ms. Slaughter demanded the yeas and nays and the Speaker postponed further proceedings on the adoption of the resolution until a later time.
