Declares the sense of the House of Representatives that the Governments of Syria, Lebanon, and Iran shall immediately and unconditionally: (1) provide a complete medical accounting of Elchanan Tannenbaum's present state of health to the International Committee of the Red Cross; (3) take all necessary measures to provide the International Committee of the Red Cross with ongoing access to Elchanan Tannenbaum; and (4) take all necessary measures to secure the release of Elchanan Tannenbaum from captivity.
