Honors the 1963 March on Washington as one of the largest political demonstrations in U.S. history and recognizes its importance in the struggle for civil rights and equal rights for all Americans. Expresses gratitude to the organizers and participants for their dedication and commitment to equality and justice.

- **Sep 16, 2003:** Mrs. Blackburn moved to suspend the rules and agree to the resolution.
- **Sep 16, 2003:** Considered under suspension of the rules. (consideration: CR H8234-8239)
- **Sep 16, 2003:** DEBATE - The House proceeded with forty minutes of debate on H. Res. 352.
- **Sep 16, 2003:** At the conclusion of debate, the Yeas and Nays were demanded and ordered. Pursuant to the provisions of clause 8, rule XX, the Chair announced that further proceedings on the motion would be postponed.
