Summary (as of Jun 23, 2004)

(This measure has not been amended since it was introduced. The summary of that version is repeated here.)

States that Congress: (1) strongly endorses the principles articulated by President Bush in his letter dated April 14, 2004, to Israeli Prime Minister Ariel Sharon which will strengthen the security and well-being of the State of Israel; and (2) supports continuing efforts with the international community to build the capacity and will of Palestinian institutions to fight terrorism, dismantle terrorist organizations, and prevent the areas from which Israel has withdrawn from posing a threat to the security of Israel.

- **Jun 24, 2004:** Received in the Senate and referred to the Committee on Foreign Relations.
- **Jun 23, 2004:** Ms. Ros-Lehtinen moved to suspend the rules and agree to the resolution.

- **Jun 23, 2004:** DEBATE - The House proceeded with forty minutes of debate on H. Con. Res. 460.
