To facilitate the resolution of a minor boundary encroachment on lands of the Union Pacific Railroad Company in Tipton, California, which were originally conveyed by the United States as part of the right-of-way granted for the construction of transcontinental railroads.

Releases, without consideration, all right, title, and interest of the United States in and to the surface portion of property located at 615 North Burnett Road in Tipton, California, which encroaches upon land originally conveyed by the United States to the Union Pacific Railroad Company as part of a right-of-way for the construction of transcontinental railroads. Declares that the United States retains any subsurface mineral rights held by it with respect to such property.
