Summary (as of Feb 12, 2003)

(This measure has not been amended since it was introduced in the House on February 11, 2003. The summary of that version is repeated here.)

Expresses gratitude for and encourages States and localities to honor the courage and sacrifice of members of the U.S. armed forces, particularly Sam Johnson of Texas, who were held as prisoners of war during the Vietnam conflict.

Calls for a full accounting of the 1,902 members of the armed forces who remain unaccounted for from that conflict.

Honors all members of the armed forces who have fought and died in the defense of freedom.

- **Feb 12, 2003:** Mr. Hunter moved to suspend the rules and agree to the resolution.
