Sets forth the rule for consideration of the bill (H.R. 4548) to authorize appropriations for fiscal year 2005 for intelligence and intelligence-related activities of the United States Government, the Community Management Account, and the Central Intelligence Agency Retirement and Disability System.

Actions Timeline

- **Jun 23, 2004:** Considered as privileged matter. (consideration: CR H4770-4778)
- **Jun 23, 2004:** DEBATE - The House proceeded with one hour of debate on H. Res. 686.
- **Jun 23, 2004:** POSTPONED PROCEEDINGS - At the conclusion of debate on H. Res. 686, the Chair put the question on ordering the previous question and by voice vote, announced that the ayes had prevailed. Ms. Slaughter demanded the Yeas and Nays. A sufficient number arose in support of the demand and the Yeas and Nays were ordered. The Chair postponed further proceedings on the resolution until later in the legislative day.

- **Jun 23, 2004:** On ordering the previous question Agreed to by the Yeas and Nays: 222 - 200 (Roll no. 286). (consideration: CR H4778, H4821-4822)

- **Jun 23, 2004:** On agreeing to the resolution Agreed to by recorded vote: 220 - 200 (Roll no. 287). (text: CR H4770)
- **Jun 23, 2004:** Motion to reconsider laid on the table Agreed to without objection.
